# **Critical Information Summary**

Service description Messaging Services provide bulk messaging services for business, which allow you to send messages via an online portal or email. The Messaging Service APIs allow you to integrate with certain

customer applications (additional charges may apply). Messaging Services are only

available to business customers with a valid ACN.

Early Termination Charges If the Messaging Service is cancelled before the end of the Minimum Service Period, then Early Termination Charges (ETC) apply. The ETC is calculated as 19% of the monthly recurring charges, multiplied by the number of months (or part thereof) remaining in the Minimum Service Period.

Alpha tag	An alphanumeric sender ID used to send one-way SMS.
Email2SMS	Text messages sent via email capability.
Mobile Landing Page	Custom built standalone webpages for mobile that recipients can click through.
Short Trackable Links	Automatically shortens URLs in text messages to 22 characters. Tracks which recipients click a link.
REST API	This API can integrate text messaging with certain applications.
Web Portal	The online portal to send text messages (among other functions) at messaging.tpgtelecom.com.au.

#### Other information

**Internet services:** You will require a suitable internet service in order to use Messaging Services and an email address if you want to send SMS via email. Internet services are not included in the Messaging Services.

**International sending restrictions:** Foreign laws and regulations may require us, our suppliers or interconnecting carriers to block or restrict sending messages to certain countries from time to time. Contact your account manager for further information.

**SMS & MMS:** Each SMS is generally charged in increments of up to 160 standard GSM characters, however where longer SMS require reassembly on delivery or where certain characters are used, additional SMS increments will be charged. MMS size limit is 410KB per message.

**SMS** messaging limit: To avoid bill shock, we automatically place the Default Monthly SMS messaging limit in your plan, however you can change this limit at any time by contacting us.

**Service availability:** We will endeavour to ensure the Messaging Service is available in accordance with the service levels described in the full terms, but we do not guarantee that the Messaging Service will operate free from faults, errors or interruptions.

**Billing:** Bills are issued each month by email. The monthly plan fee is payable in advance and any additional charges are billed in arrears. If you need help understanding your bill, you can contact us via telephone on 1800 959 291 (option 3, Monday to Friday, 9am – 5pm).

**APIs:** The Messaging Service may be configured to integrate with certain customer business applications. Contact us to find out more about what integrations are available.

Equipment: We do not provide any equipment in connection with the Messaging Services.
